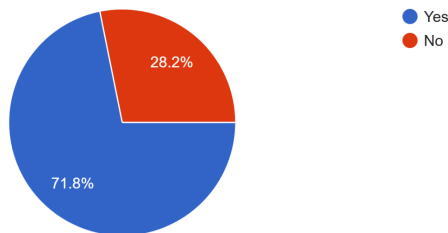
## 1. Section III: Team Roping Mixed

### Add to Section (9):

A woman will be allowed to enter without a partner. She is required to notify the entry line as to who her partner will be prior to the end of call backs. She will retain her position drawn in this case. If a partner is never obtained during callbacks, the woman will be assessed a \$50 fine (split between M-SRA & Entry line) **and will be drawn out.**

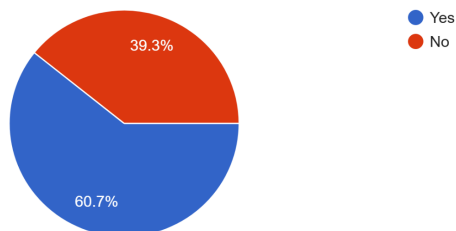

**8-12 entries pay 3 places at 50 – 30 – 20%**

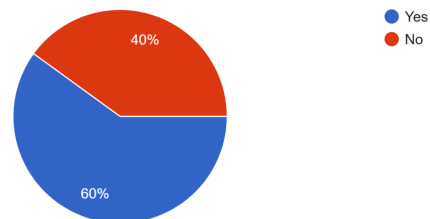
**13-18 entries pay 4 places at 40 – 30 – 20 – 10%**

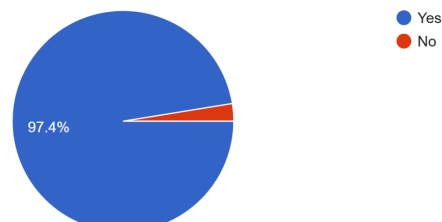

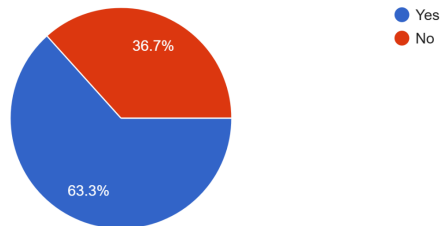

They will be allowed to run their stock/make their run on Saturday at a time designated by the MSRA board. Said contestant will pay an added charge set by the board to cover the judges/timers wage. The ground will be tractored in typical fashion and the contestant will take the ground as is. Regardless of how contestant places in the first round they will go first in the second round in all timed events, except the barrel racing in which they will go last.

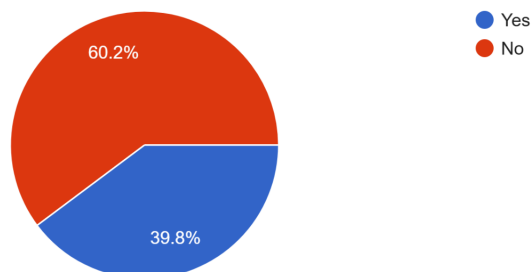


## 6. Chapter III, Article I, Section I

24) Stand alone roughstock and/or timed events will **ONLY** be approved and have to OCCUR during the time period of after the m-sra finals and until the first full rodeo of the following season and will pay the \$6.00 finals fund per contestant and the 6% event money. In order for money won to count towards the M-SRA standings, contestants **MUST** enter and compete in at least 4 approved Mid-States full rodeos.

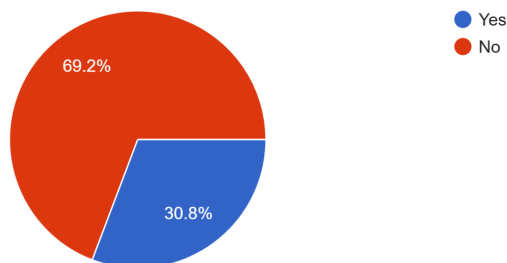

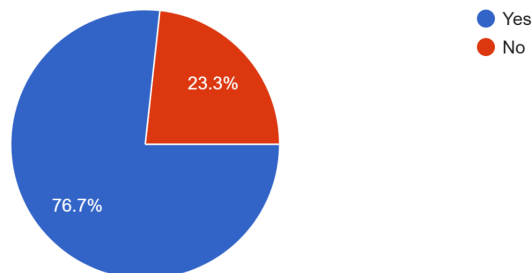

## 9. Proposed Amended Rule

### Membership Card Requirements for Contract Personnel and Competing Members

#### Section [x]: Amended Membership Provision

**In the event that an individual qualifies as both contract personnel and a competing member, such individual shall be required to purchase only one membership card to maintain good standing within the organization.**

**Dual Status Recognition:** an individual who simultaneously holds the status of Contract Personnel and Competing Member shall not be obligated to obtain multiple memberships

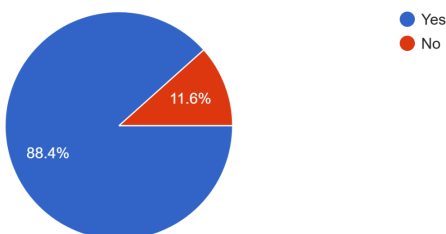
**Higher Rate Applies:** If one category of memberships carries a higher fee than the other, the individual shall be required to pay the **higher membership rate**. Payment of the higher rate shall render the individual eligible for the rights, privileges, and obligations associated with both Contract Personal and Competing Member membership.

**Scope of Rights and Privileges:** The single membership card purchased under this provision shall confer all rights, benefits, and obligations ordinarily applicable of both classification.

**Compliance Requirements:** The individual shall remain subject to all other organizational rules, codes of conduct, and contractual obligations associated with each category of membership.

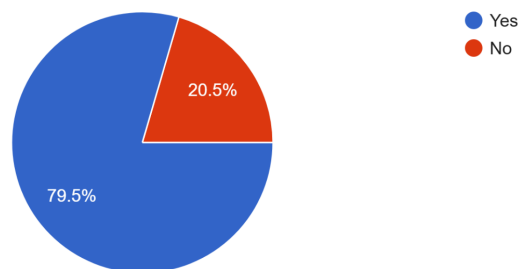


## 10. General Timed Event Rules: (New Rule)

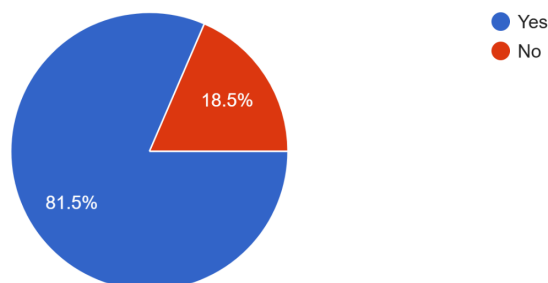

(12) Stocks contractors, judges, clowns and contract persons may work one first approved M-sra rodeo without a card, and must become members of the M-sra prior to participation in a first approved M-sra rodeo. To be eligible for the M-sra finals rodeo: stock contractors, judges, bullfighters and contract persons must be a M-sra member and work the three required rodeos, and at least one of the rodeos must be a FIRST approved M-SRA after purchasing a membership card. Name will automatically be added to the list for the finals ballot if the above has been compiled with. Timed event contractors must be a M-SRA member and work the three required rodeos after purchasing a membership card in order to be eligible for the finals.***
