1. 2022 M-SRA Executive board will conditionally co-approve acceptable standalone events, that meet criteria necessary to satisfy the requirements outline in rule proposal #2, for the 2022 rodeo season on trial basis and be re-visited for further review at the 2022 general membership meeting. -Proposed by: Jason Schnoor

3. All enter twice team roping events, both monies will count in the standings, should the contestant win two monies with ONLY the higher dollar amount county toward the All Around standings at qualifying contests for All Around monies to be earned. -Proposed by: Jason Schnoor \_\_\_\_\_YES \_\_\_\_\_NO
4. For money to count toward the All Around standings, whether it is a first approved M-SRA or co-approved, it MUST be a full rodeo. -Proposed by: Jason Schnoor \_\_\_\_\_YES \_\_\_\_\_NO
5. Team Roping Event Only – Minimum of \$100 fees + office charges at all 1<sup>st</sup> approved M-SRA rodeos

6. In the Team Roping event ONLY, payoff will be based solely on the number of teams entered (regardless of added money or total money in the purse).

Proposal payoff will be as follows:

### Entries - Places Paid - %'s

2-5 - 1 place - 100%

6-10 – 2 places - 60%, 40%

11-15 – 3 places - 50%, 30%, 20%

16-25 – 4 places - 40%, 30%, 20%, 10%

26-35 – 5 places - 30%, 25%, 20%, 15%, 10%

36-50 – 6 places – 29%, 24%, 19%, 14%, 9%, 5%

51 & over – 8 places – 23%, 20%, 17%, 14%, 11%, 8%, 5%, 2%

7. Returning members, new members, stock contractors and contract personnel will pay \$145 for their membership, regardless of the time of year the card is purchased. Gold Card members (20+ year members – does not have to be consecutive) will pay \$95. \*\*\*Refer to the membership tab on the M-SRA website to see current membership rates.

- **New member (Rookie) \$145.** Break down of membership fees:

\$95 would go to the Association (as all membership dues) and \$50 would go into a side pot to be won back by the rookies at the end of the year. Money would be split equally between men and women rookies. Pay off would be split 60%, 40% payout for champion and runner up men's rookie and 60%, 40% payout for champion and runner up women's rookie.
